THIS MONTH IN AMERICAN REVOLUTION HISTORY

The Siege of Savage's Old Fields (also known as the first siege of Ninety Six, November 19–21, 1775) was an encounter between Patriot and Loyalist forces in the back country town of Ninety Six, South Carolina, early in the American Revolutionary War. It was the first major conflict in South Carolina in the war, having been preceded by bloodless seizures of several military fortifications in the province. Patriot forces under the command of Major Andrew Williamson had been dispatched to the area to recover a shipment of gunpowder and ammunition intended for the Cherokees that had been seized by Loyalists. Williamson's force, numbering over 500, established a stockaded fort near Ninety Six, where it was surrounded by some 1,900 Loyalists. https://en.wikipedia.org/wiki/Siege_of_Savage%27s_Old_Fields

Old Business:

- Diane Borgman reminded us that the Revolutionary War in the West celebration will be held in Ste. Genevieve, Missouri in May 2022

New Business:

 Historian/Registrar Dennis Hahn gave a a report on the October 30th meeting of the Board of Directors of the Missouri Society SAR. He reported that we have 801 Compatriot Members statewide, and Fernando de Leyba Chapter is the largest Chapter in Missouri with 119 members (based upon the State Society's handling of Dual Members).

Dennis also mentioned that, as Chairman of the Committee, he was working on revising the format of the Josiah Fogg award. He also related that the Board had changed the Chapter Yearbook format to digital.

The April Annual Meeting of MOSSAR will be sponsored by Spirit of St. Louis Chapter at the Westport Hilton hotel, and information will be coming soon.

- Compatriot Keith Morris announced that the Wreaths Across America dedication will be held on December 19th at Jefferson Barracks National Cemetery in conjunction with Spirit of St. Louis Chapter. More information will follow via e-mail.
- An extended discussion was held regarding the current situation going forward with the Embassy Suites for our month meetings. The hotel has proposed an approximate monthly cost with a buffet of approximately \$650 per month. Members and guests who wish to partake in the buffet will be charged approximately \$25 or more each.

A study was made as to alternate locales available for our September through June meetings. The ultimate, unanimous decision was made to move our meeting venue to the Community Council of St. Charles County, 427 Spencer Road, Ste. 255, St. Peters, MO 63376. The Community Council Offices are in the Northern end of the Spencer Road Library. The venue will be at a cost of \$250.00 annually.

Attendees who wish to eat before the meeting may bring food into the meeting room, with the caveat that each will be responsible for trash clean up. One of the requirements is that the meetings must end at 9:00 PM, so we will be moving our start time to 6:30 PM.
